Almost 60% of occupational pension funds incorporate SRI into their investment strategies. Over the past ten years, there has been a 32% growth per annum in the value of ethical funds in the UK.

Russell Sparkes, a Fund Manager with the Central Finance Board of the Methodist Church will be chairing the event. In 1994 he joined the Central Finance Board of the Methodist Church (CFS). His primary responsibility is the day to day management of the CFB Overseas Fund. He is also Secretary to the Joint Advisory Committee on the Ethics of Investment. He is the author of The Ethical Investor, a handbook on practical ethical investing, published by Harper Collins in 1995. He served on the Board of the UK Social Investment Forum for a number of years.

**Penny Shepherd** has been Executive Director of the Social Investment Forum since 1997. She will cover the study undertaken by the UK Social Investment Forum of the response of UK Pension Funds to the new SRI Disclosure regulation. She will also look at the size of SRI in the UK.

Emma Howard Boyd is head of the research unit at Jupiter Asset
Management and has been a researcher for SRI funds since 1994. She will
compare how strategies vary between funds that are considered SRI.
